Market Technical Outlook



The Nifty opened higher but was unable to sustain the opening gains and selling during the day drag nifty to close in red. On the daily chart, we are observing an inside day formation which suggests indecisiveness prevailing at current level. In coming trading session if nifty trades above 23590 level then it may test 23630 - 23725 levels. On the downside, 23400 – 23280 may act as support for the day.

We still maintain our stance that 23600 – 23800 is strong supply zone on daily closing basis. Hence, one needs to adopt cautious approach at current level.
