The Nifty opened higher, traded with positive bias throughout the day to close in green. On the daily chart, we are observing an inside day formation which suggests that markets are circumspect at current level. In coming trading session if nifty trades above 23350 level then it may test 23425 – 23550 levels. On the downside, 23210 – 22105 levels may act as support for the day.

We maintain our stance that nifty has good demand zone of 22830 - 23000 from where bounce cannot be ruled out. Hence, one needs to adopt cautiously positive approach at current level as stock specific activity is likely to continue.
