Nifty opened on a positive note but failed to sustain the initial gains, eventually succumbing to selling pressure and closing in the red. On the daily chart, the index has settled below both the 10-day and 21-day Simple Moving Averages (SMA) at 24,769 and 24,697 respectively, indicating emerging weakness in the near term. In the upcoming trading session, a move below the 24,500 level could trigger further downside, with potential support seen around 24,450 - 24,360 levels. On the flip side, resistance is likely to emerge around the 24,650 – 24,735 levels. The closing below both short-term SMAs reinforces a bearish undertone. Additionally, the Relative Strength Index (RSI) is showing a negative divergence, suggesting increasing downside momentum. Given these signals, a cautious trading approach is advisable at current levels.


