Market Technical Outlook



The Nifty opened higher, but trade volatile with positive bias. On the daily chart, we are observing prices closed above 50-day SMA and it has given "Trendline" breakout, which indicates we can see positive momentum remain continue with stocks specific action. In the coming trading session if nifty trades above 24750 level, then it may test 24830 - 24880 levels. On the downside 24630 - 24550 levels may act as support for the day.

Since prices are trading above the 50-days SMA, one needs to adopt a cautiously positive approach at current level.
