**Market Technical Outlook** 

The Nifty commenced the session on a strong note with a gap-up opening and maintained a positive bias throughout the day, closing firmly in the green. On the daily chart, a prominent bullish candle has been observed, which has closed convincingly above the 200-day Simple Moving Average (SMA) of (24,046) sign of strengthening market sentiment. In the upcoming trading session, if the index sustains above the 24,950 level, it may potentially test the next resistance levels at 25,030 - 25,145. On the downside, support is expected around the 24,830 – 24,720 levels.

Currently, the Nifty is trading comfortably above the short-term 10-day and 20-day SMAs, placed at 24,380 and 23,956 respectively, and is well above the 200-day SMA. This alignment reinforces the likelihood of continued upward momentum. However, it is important to note that momentum indicators RSI is still reflecting negative divergence, which warrants a cautiously optimistic approach at current levels.
