## Market Technical Outlook



The Nifty opened higher traded in a narrow range with positive bias to close in green. On the daily chart, we are observing a “Doji” candlestick pattern which suggests indecisiveness prevailing at current level. In coming trading session if nifty trades above 23225 level then it may test 23290 – 23400 levels. On the downside, 23100 – 23000 levels may act as support for the prices.

Since prices are still trading below the rising 200-days SMA (23954), one needs to adopt cautious approach at current level.
