The Nifty opened with a downside gap but managed to recover part of the losses during the session, eventually closing in the red. On the daily chart, a gap down reversal candlestick pattern has emerged, suggesting the possibility of an extended pullback rally. Typically, such downward gap **areas** act as resistance zones for prices. In this case, the gap between 24,825 and 24,754 is likely to serve as a key resistance range. In the upcoming trading session, if the Nifty sustains above 24,754, it may attempt to test levels of 24,832 to 24,910. On the downside, the zone between 24,600 and 24,500 is expected to provide support.

Currently, the index is trading below both the 10-day and 21-day SMAs (24,858 and 24,841, respectively), which warrants a cautious approach at current levels. Nevertheless, stock-specific activity is expected to remain resilient and may continue to offer trading opportunities.
