### Market Technical Outlook



The Nifty opened up with a gap and momentum on the upside intensified as the day progressed which led nifty to close on a strong note. On the daily chart we are observing that prices have reclaimed the 20-day SMA (22573). This suggests that momentum on the upside is likely to continue. In coming trading session if nifty trades above 22860 then it is likely to test 22940 – 23050 levels. On the downside, 22710 – 22635 levels may act as support for the day.

As, we had mentioned that as long as nifty holds the 10-days SMA (22397) there is high probability that nifty may test 22800 – 23000 levels in couple of weeks. At present, nifty has hit our first target of 22800 and is likely to test the second target of 23000. Hence, one needs to adopt cautiously positive approach at current level.
