**Market Technical Outlook** 

The Nifty opened lower traded with negative bias throughout the day to close in red. On the daily chart, we are observing three consecutive bear candle. Further we are observing that prices have convincingly close below the falling 50-day SMA (24374) which suggests weakness. In coming trading session if nifty trades below 24160 level then it may test 24100 – 24000 levels. On the upside 24300 – 24410 levels may act as resistance for the day.

Since, prices are trading above the rising 200-days SMA (23790) & below the falling 50-days SMA (24374), one needs to adopt cautiously positive approach at current level.
